## CHANGES TO ORIGINAL PLAN

## SUMMARY OF TESTING METHODS AND KEY FINDINGS

Five facilities were selected for testing using data from 1Q 2021. The patient records for the selected facilities were imported and calculated during the normal business process. The QRDA I files were generated for the five facilities and submitted to CMS in the Test environment. The error reports were downloaded and reviewed.
