JUSTIFICATION FOR REAL WORLD TESTING APPROACH

HCA Healthcare has a self-developed Patient Portal Module, MyHealthONE, which is made available for use by patients treated within the HCA Healthcare organization.

Real world testing for the standards subject to the real-world testing rules codified in 45 CFR 170.405(b)(1)(iii) will be limited to patients of HCA Healthcare who have created a MyHealthONE patient account.

MyHealthONE Patient Portal - 170.315(e)(1): View, Download and Transmit

Users can access the MyHealthONE product from a desktop PC or mobile device in the United States, Canada, and Mexico.

To complete real world testing, a query will be run to determine the number of MyHealthONE users who accessed MyHealthONE and were able to view, download, or transmit their health information, as defined in USCDI v1 as available.

Metrics will be collected for the following:

- Total number of unique patients at HCA Hospitals.
- Total number of unique hospital patients/users with a MyHealthONE account linked to their health information.
- Total number of times unique hospital patients/users viewed their health information via MyHealthONE.
- Total number of times unique hospital patient/MyHealthONE users downloaded their health information.
- The percentage of hospital patient/MyHealthONE users who downloaded their health information.
- Total number of times unique hospital patient/MyHealthONE users transmitted their health information to a third party using the Direct or email method.
- Percentage of hospital patient/MyHealthONE users who transmitted their health information.
- Total number of times an authorized representative/proxy used MyHealthONE to access the health information of a patient.
- Total number of hospital patients/MyHealthONE users who viewed their activity log.



These metrics and associated findings will be compiled and incorporated into the RWT (Real World Testing) Results Report.

EXPECTED OUTCOMES

Expected Outcomes

The outcomes HCA expects to observe via this real-world test plan include determination of high volume of frequently used VDT (View, Download, and Transmit) capabilities within MyHealthONE. The volume of unique users will reflect the number of persons that were enabled to interact with the electronic health information for themselves and others within a given timeframe.

It is expected that the volume for "view" events will be greater than the events for downloading and transmitting, as view actions are the primary actions associated with MyHealthONE Web and Mobile applications. Download and transmit features in MyHealthONE are accessed less frequently and thus will have lower volume of events. Similarly, we expect to see low volumes of activity log events in comparison to view events. This is because, while providing an important function, activity logs are only utilized by the patients on rare occasions.
